COURSE PROVISIONS

1. Premier Driving academy will provide a minimum of 24 hours of classroom instruction, 6 hours of behind the wheel (BTW) instruction and, 4 hours of observation time in a dual controlled automobile, fully insured, covering each student enrolled in the program. Classroom instruction must be a minimum of 3 weeks in length. BTW instruction shall not begin until the student has received a minimum of 4 hours of classroom instruction. BTW instruction must be completed no later than 3 weeks after the classroom instruction has been completed.

NOTICE: Premier Driving Academy is required to be certified by the Secretary of State. If you have any complaint, which you cannot settle with this provider, write: Michigan Department of State, Driver Programs Division, Lansing, MI. 48918. Completion of driver education instruction does not guarantee qualification for a driver license.

TERMS

1. The student must be 14 years 8 months of age by the first scheduled day of class (verification by birth certificate required)
2. The TOTAL COST of Premier Driving Academy Segment I class is \$_____. This cost cover's everything including materials, books, driving with instructors. The Parent or Guardian agrees to pay this amount in full. The student is required to pay a registration fee of at least \$130 on the first night. This will be applied toward the total cost of the course. The remainder of the fee must be paid in full by the end of the second week.
3. By signing this contract the student and Parent/guardian understand that the student can be expelled from the course if you do not conduct yourself properly while in or about the class facilities and show due respect to class instructors as well as your fellow students. If expelled, the course refund policy would apply.
4. Issuance of a Driver's Education Certificate is permitted only after the student has met all class room teachers expectations and has passed the STATE TEST with a score of 70% or higher.
5. In the event of a missed scheduled driving appointment a fee of \$25 will be charged for a make up drive.
6. In the event of an absence Premier Driving Academy provides one make up day at no charge. For the Second absence there will be a \$30 dollar fee is applied. Three absences and the student must repeat the course at a pro-rated fee.
7. First week payment can be paid in Cash, money order or check. There after all payments must be by Cash or Money order.

REFUND POLICY

1. If you do not complete the course, only 50% of the course fees are refundable up to the end of the first week. From the first to the second week, 40% will be refunded, there after no part is refundable. If a student has driven any hours with an instructor, Premier will keep \$25 per hour of driving from the total amount of the refund.
